# Park Security, Mike Janin

Mike noted that the recent smoking policy recommendation of the PAC had been unanimously approved by the THPRD Board of Directors. The smoking ban will take effect, February 1, 2014.

Mike suggested that the PAC should send a thank you letter to Carla Bennett for taking the time to attend the Board of Directors meeting and testify. Mike also suggested we should send a note to Blaire Thomas to thank him and let him know the final status of his efforts. The committee agreed and Mike and Greg will compose and send.

Mike also reminded the committee of the results of the three neighborhood meetings conducted to determine the level of community support for the off-leash proposal. There was consistent opposition to the proposal at all sites with no one expressing approval.

### Parks Maintenance, Dave Chrisman

Dave provided a brief update on the Winkelman Dog Park which is currently closed to allow for turf recovery. The all-season bark chip area remains open. Staff will review possible remedies to minimize turf wear at the top of the hill where most dogs and owners congregate. A gravel pathway system to draw visitors into the outer areas of the park is under consideration.
